**Venue**: Strathfield Park Synthetic Field I (closest to the Red Roof Cafe), Chalmers & Homebush Rd, Strathfield NSW 2135

**Time**: 2.00pm-4.00pm (<u>participants must arrange their own travel to and from the venue</u>). We ask that students arrive at the ground at 1:45pm to have their name marked off and are prepared to take the field at 2:00pm. Convenors will be waiting on the synthetic field.

**Dress**: Mouth guard (compulsory), sports attire, boots and other protective gear i.e. headgear.

The synthetic field at Strathfield Park ensures that the trials will proceed <u>even in wet conditions</u> In the case of extreme weather (lightning), schools will be notified.

Please send **Stage 3** students who <u>regularly play</u> AFL (PSSA or club) and are of a representative standard. Please contact your relevant convenor if you have a Stage 2 student of that standard to discuss their eligibility. <u>Only boys will be allowed to trial as girls have their own separate pathway</u>.
